TERMS AND CONDITIONS OF MEMBERSHIP

1. All applications are referred to the WSA Board of Directors and are approved by no less than two-thirds affirmative vote.
2. Membership dues are based on the Company's gross annual business for the previous 12 months and calculated according to the dues schedule on the reverse side.
3. Applicant must be an owner, partner or officer of a business concern primarily doing business as a stocking wholesaler-distributor in plumbing, heating, air conditioning supplies, and/or pipe, valves and fittings for a period of not less than one year.
4. Applicant's primary source of supply must be from established manufacturers of plumbing, heating and air conditioning suppliers and/or pipes, valves and fittings.
5. Applicant shall not be considered a wholesaler, nor eligible for membership, if his primary distribution is to the general public which normally is serviced by retailers. Applicant's method of distribution must be to:
 - A. Licensed plumbing, heating, air conditioning, sprinkler or mechanical contractors.
 - B. Established retailers of plumbing, heating and air conditioning products and/or pipe, valves and fittings.
 - C. Industrial establishments, including manufacturing plants, hotels, public buildings, schools, school districts, colleges and universities, oil and gas entities, irrigation establishments, public utilities, and other recognized establishments employing maintenance personnel.
 - D. Government and/or public institutions.
